- Dylan Thomas (1914-1953)

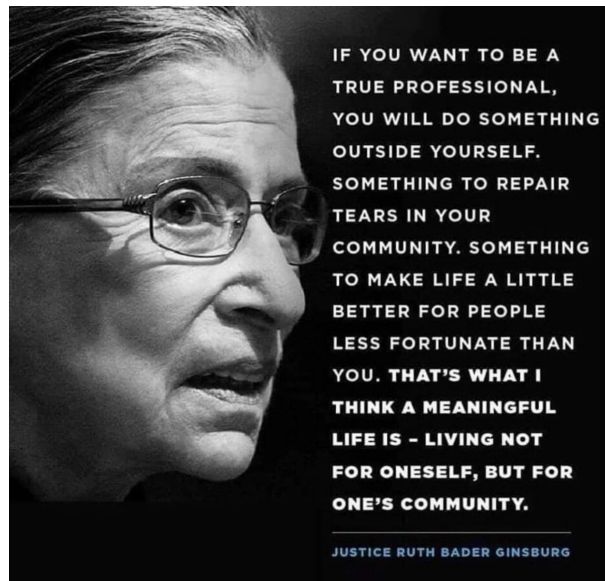
Dear Mrs. Ginsburg,
